### Fund objective and strategy

The Fund seeks to maximize total return. Investing in fixed-income securities across more than 60 emerging market countries, focusing on corporate issues throughout the credit quality spectrum. While the fund may invest in locally denominated bonds, it restricts its exposure to currencies outside the U.S. dollar and other hard currencies to no more than 20% of portfolio assets.

**About credit quality:** Credit quality ratings are sourced from Standard & Poor's (the "S&P"), Moody's and Fitch's and based on issuers with ratings. Ratings values are based on the middle of three rating agencies S&P, Moody's and Fitch. If only two of the ratings are available then the lower rating of the two will be used. If none of the rating agencies have assigned a rating the Fund will assign a rating of NR (non-rated security). The ratings represent the agencies (S&P, Moody's, Fitch's) opinions as to the quality of the securities they rate. The ratings range from AAA (S&P, Fitch's) or Aaa (Moody's) (extremely strong capacity to meet its financial commitment) to D (S&P, Fitch's) or C (Moody's) (in default).
