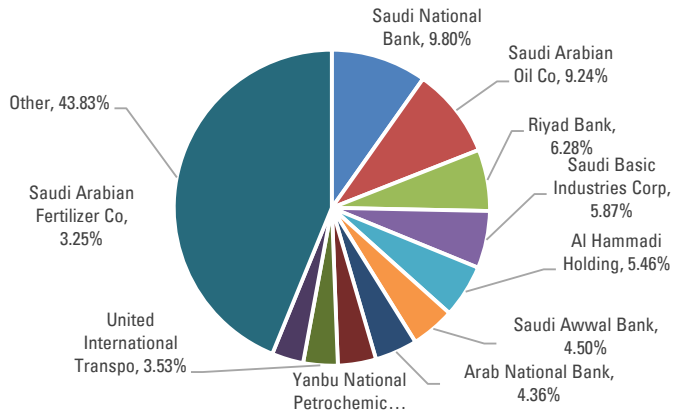

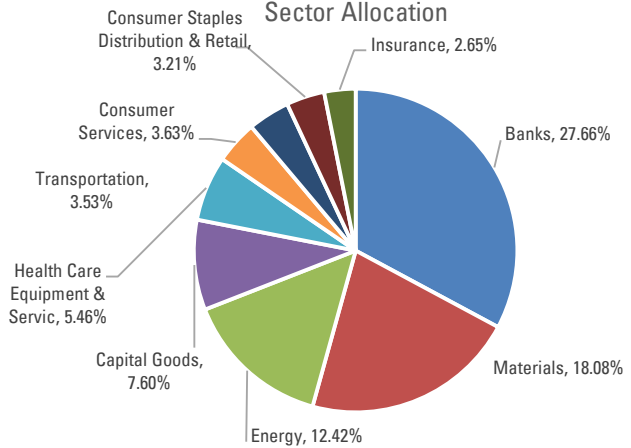

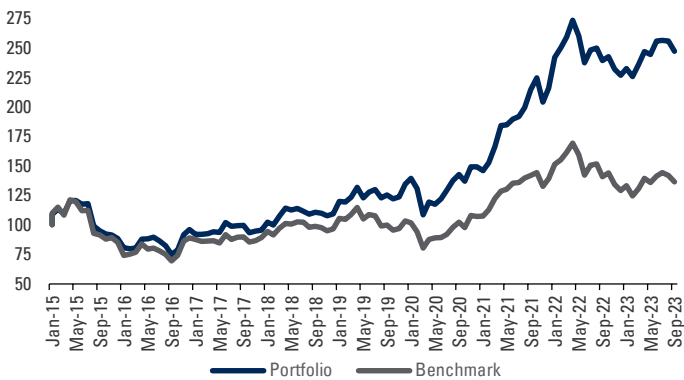
Top 10 Holdings
